Dear Members of the Joint Select Committee on Deficit Reduction:

The members of the Campaign for Housing and Community Development (CHCDF) would like to thank you for agreeing to serve as a member of the Joint Select Committee on Deficit Reduction charged with recommending further actions to reduce the federal debt.

CHCDF is an education, strategy and action hub for national organizations dedicated to adequate federal housing and community development funding for low-income families and communities. CHCDF members represent a full continuum of national housing and community development organizations, including faith-based, private and public sector, financial intermediary, civil rights, developer, and advocacy groups. These groups work to meet the needs of low and moderate income renters and homeowners in urban, suburban, rural and tribal communities, including the elderly, people with disabilities, and people experiencing homelessness.

We write to you today with a simple request: we ask that your Committee only support proposals, whether to raise revenue or cut spending, that do no harm to low income Americans. This includes ensuring that low income households do not experience increased housing or other cost burdens due to cuts in assistance programs. The debt limit agreement acknowledged this important principle in exempting many low-income (mostly entitlement) programs from sequestration. Yet the ten-year discretionary spending caps enacted into law will have a disproportionate impact on low-income families. These households should not be asked to bear the burden of additional sacrifice.

Further cuts in nondefense discretionary spending would likely decimate federal housing and community development programs. These programs are efficient and have powerful impacts on individual and community well-being, not only directly by supporting stable housing for vulnerable people, but also through their effects on economic growth, education, employability, community health, and job creation, particularly for those at the bottom of the economic ladder who have been hardest hit by the recession.

To achieve deficit reduction that does not further harm low-income Americans, it is essential that the Committee consider expenditures beyond nondefense discretionary spending and include significant revenue increases in any agreement endorsed by the Committee. As the Committee examines tax provisions, we urge you to recognize that several tax expenditures facilitate community development investments and expand the availability of affordable housing for low income households and so should be protected.

Thank you for your consideration of these views. Members of our organization stand ready to meet with you or with the Committee staff, to provide additional information about the importance of providing affordable housing to everyone in our country.
