



**Chris Estes** is NHC's president and CEO. Chris began his tenure at NHC in July 2012, coming from North Carolina, where he led the North Carolina Housing Coalition for nine years. Chris leads the organization's strategic direction for its policy, communications and research work and serves as a national thought leader on affordable housing and community development issues. He is a graduate of the University of North Carolina-Chapel Hill, where he majored in economics and industrial relations. He also has two masters' degrees from UNC-CH in social work and city and regional planning. He currently serves on the board of directors of the Baltimore Branch of the Federal Reserve Bank of Richmond and the National Low Income Housing Coalition, as well as the Fannie Mae Affordable Housing Advisory Committee.

**Amy Clark** is senior director of marketing and communications at the National Housing Conference, where she leads the development and execution of NHC's strategic communications efforts to elevate housing affordability as a first-tier issue on the national agenda. At NHC, she manages brand, marketing and media relations efforts as well as leading the organization's communications program, which includes research, online resources and training and education for the housing community.
