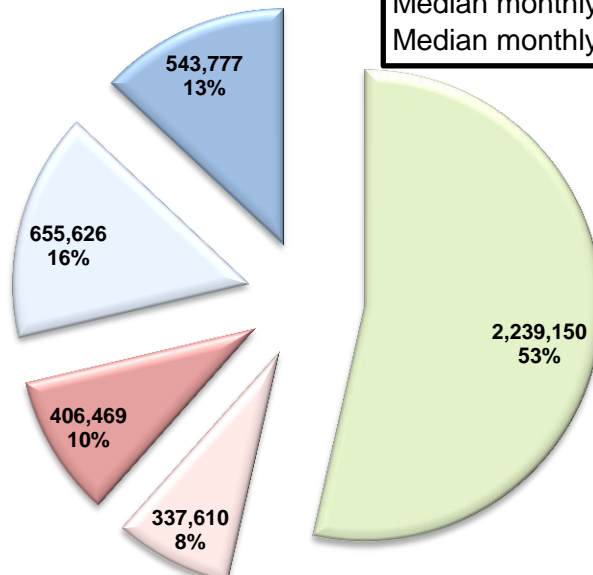


## Housing Affordability Challenges in the Los Angeles Metro Area

- In the Los Angeles metro area, 993,236 households, or 23% of households, spend at least half of their income on housing costs. Nationwide, 15% of all households are severely cost burdened.
- Renters are more likely to be severely housing cost burdened than owners, with 30% of renters spending at least half their income on housing.
- Median household income in the Los Angeles metro area is \$59,042, compared to the median U.S. household income of \$52,393.
- Among low- and moderate-income working households, 37% of households spend at least half of their income on housing costs.

### Households with a Severe Housing Cost Burden

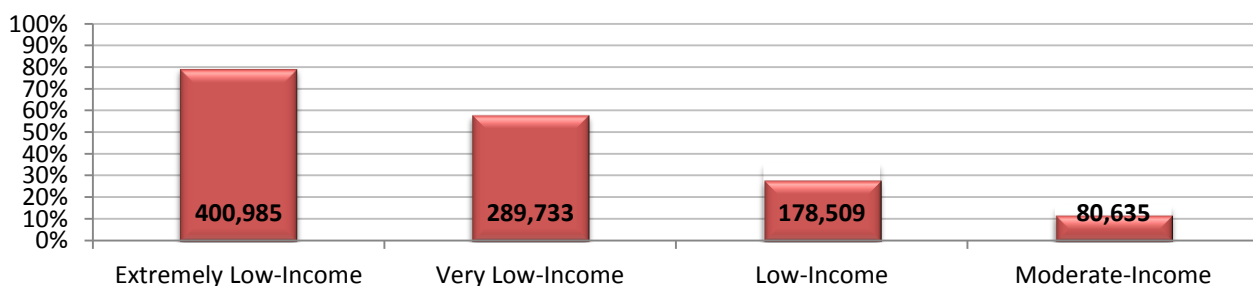
- Households spending less than 30% of their income on housing

### Los Angeles Metro Area Households: 2013

Total households 4,251,497  
 Renters make up 52% of households  
 Owners make up 48% of households  
 Median household income is \$59,042  
 Median monthly owner housing cost is \$1,250  
 Median monthly renter housing cost is \$1,829

## Working Households with a Severe Housing Cost Burden

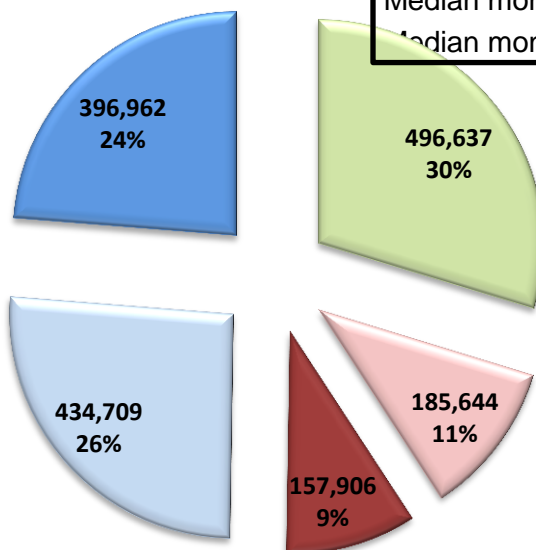
Households spending less than 30% of their income on housing

Owner households spending at least half their income on housing

Owner households spending between 30% & 50% of their income on housing

Renter households spending at least half their income on housing

### Los Angeles Metro Area Working Households: 2013

Total households 1,671,858

Renters make up 69% of households

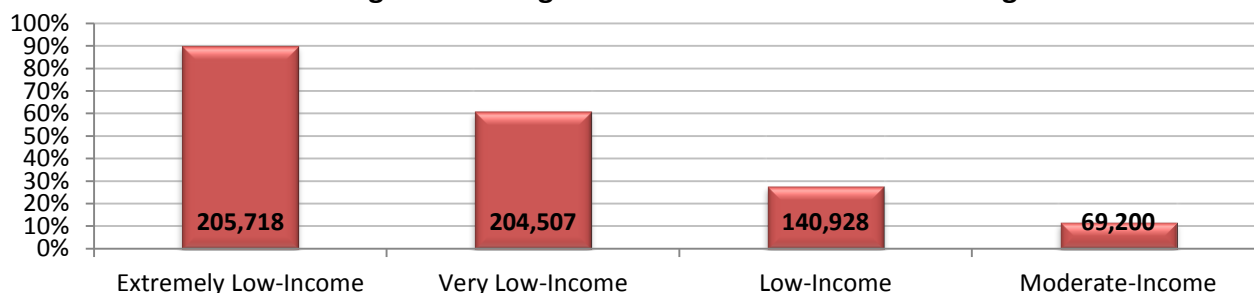
Owners make up 31% of households

Median household income is \$38,891

Median monthly owner housing cost is \$1,603

Median monthly renter housing cost is \$1,163

## Percentage of Working Households with a Severe Housing Cost Burden



### Definitions

**Severely Housing Cost Burdened:** Households who spend at least half of their income on housing costs.

**Extremely Low-Income:** Households who earn 30 percent or less than the median income for households in their area (AMI).

**Very Low-Income:** Households who earn between 31 and 50 percent of AMI.

**Low-Income:** Households who earn between 51 and 80 percent of AMI.

**Moderate-Income:** Households who earn between 81 and 120 percent of AMI.

**Working:** Households whose members work a total of at least 20 hours a week on average.

**Metro Area:** Metropolitan area defined by the Office of Management and Budget.
