Dear Chairman Inouye and Vice Chairman Cochran,

We write in strong support of the Interagency Partnership for Sustainable Communities, which links the Department of Transportation (DOT), the Department of Housing and Urban Development (HUD) and the Environmental Protection Agency (EPA) in an unprecedented collaboration to coordinate federal housing, transportation, and environmental investments. We encourage you to make this innovative collaboration possible by approving the President's request for funding in the FY2011 budget for the Sustainable Communities programs within HUD, DOT and EPA.

We believe that the President's FY2011 budget for the Interagency Partnership for Sustainable Communities is an important step in making communities of all sizes and locations more economically competitive, healthy, safe, socially inclusive and environmentally sustainable. These resources are essential for small towns, rural communities, and underserved urban areas to undertake the planning necessary to meet changing housing and transportation demands; improve community health outcomes; connect workers to jobs and economic opportunity, strengthen regional economies; provide greater household stability through access to goods and services; and create transit-rich, safe, walkable and bikeable neighborhoods.

Specifically, we support:

- \$150 million for HUD's Sustainable Communities Initiative to enable HUD to continue supporting comprehensive regional and community planning efforts that integrate transportation and housing investments that result in more regional and local sustainable development patterns, reduce greenhouse gases, and increase more transit accessible housing choices for residents.
- \$20 million for DOT's Office of Livable Communities to help the Secretary coordinate livability and sustainability work throughout the Department and coordinate with similar programs at HUD and EPA.
- \$200 million for the Federal Highway Administration to help state and local governments integrate planning processes for transportation, land use and natural resource conservation. These funds could be used for improved modeling, data collection and assessment tools to meet sustainability goals through transportation investments.
- Full funding for Federal Transit Administration (FTA) programs to help state and local governments invest in transportation infrastructure that reduces greenhouse gases, improves mobility and access for disadvantaged people, and increases housing choices.
- At least \$11.23 million for EPA's Sustainable Communities Initiative funded through its successful Smart Growth Program, allowing the agency to fully participate in the Partnership for Sustainable Communities and to continue providing direct technical

assistance and research to help communities meet economic and environmental challenges with sustainable solutions. The Smart Growth program has absorbed a number of other staff and programming duties due to internal restructuring, and we have concerns about how much money will be diverted away from technical assistance to cope with added administrative responsibilities. Therefore, we support an increase of funding for EPA's Smart Growth Program in FY 2011 to adequately assist communities in implementing the Partnership's sustainability initiatives.

The Interagency Partnership for Sustainable Communities represents a vital opportunity to effectively coordinate and leverage federal programs for the greatest impact on long-term community well being. We urge you to support these important programs in the FY 2011 Appropriations process.
