

A recipient of the University of North Carolina Distinguished Alumnus Award, Mr. Bynum has been honored with the Aspen Global Leadership Network McNulty Prize, National Housing Conference Visionary Award, Opportunity Finance Network Gramlich Award, National Federation of Community Development Credit Unions Vamper Award, National Credit Union Foundation Wegner Award, Ernst & Young/ Kauffman Foundation National Support of Entrepreneurship, National Rural Assembly Rural Hero Award, African American Credit Union Coalition Pete Crear Lifetime Achievement Award and The Wall St. Journal/Met Life Foundation Financial Inclusion Challenge.

## 2019 HOUSING VISIONARY AWARD

THE CALIFORNIA BALLOT INITIATIVE TEAM: RAY PEARL, LISA HERSHEY, CARL GUARDINO AND CESAR DIAZ

In November 2018, Californians headed to the polls with their hearts and convictions placed on affordable housing and voted to pass Propositions 1 and 2. The winning result was a combined \$6 billion for affordable housing and supportive housing for lower-income Californians and for people at risk of chronic homelessness while living with mental illness. Proposition 1, the Veterans and Affordable Housing Act, received 56 percent of the vote. Proposition 2, the No Place Like Home Act, received 63 percent.

California's collaborative approach is a unique coordination of a broad range of advocates. Four diverse organizations led campaign efforts: Ray Pearl, California Housing Consortium; Lisa Hershey, Housing California; Carl Guardino, Silicon Valley Leadership Group; and Cesar Diaz, State Building and Construction Trades Council of California.





RAY PEARL
California Housing Consortium

Ray Pearl became the Executive Director of the California Housing Consortium in March 2009. As the Executive Director, Ray is responsible for leading the premier "big tent" housing

advocacy organization representing the development, building, financial, and public sectors united in a non-partisan effort to advance affordable housing and community development across California.

Prior to joining the Consortium, Ray spent many years in the private sector working in the government affairs and land use planning departments of two major Southern California development companies. He also has extensive experience in association management and housing policy advocacy through

He was also active with his children's soccer teams through AYSO and was elected to serve on the Westlake Village City Council in 2018.

**LISA HERSHEY** Housing California

Lisa Hershey serves as Executive Director for Housing California. Since 1988, Housing CA has worked to prevent and end homelessness and increase the variety and supply of safe, stable,

accessible and permanently affordable homes in vibrant, inclusive, and prosperous communities. Housing CA achieves its goals through advocacy and education in the State Capitol; advancing the field with strategic communications and the largest affordable housing conference in the country; marshaling the power of wide and growing multisector coalitions to connect housing to jobs, transportation, health, and education; and building leadership among and organizing residents and staff of affordable housing through our Residents United Network to include their powerful voices in the fight for a California for all. During Lisa's tenure as Executive Director, Housing CA has accomplished unprecedented success, including helping to secure billions of dollars for affordable and supportive housing funding through the legislature and state ballot initiatives.

Prior to joining Housing CA in May 2014, Lisa worked for five years in the nonprofit sector as the Public Health Institute's (PHI) Program Director for California Convergence, a statewide network of people who are passionate about creating healthy, safe, and equitable communities where every person participates and prospers. Lisa gained invaluable experience through 21 years in state and local public sector roles, including managing vanguard, department-wide public health, equity and place-based initiatives and advising the California Department of



Health Services/Public Health (CDPH) Directorate. She has helped raise billions of dollars and orchestrate inclusive, collaborative policy action among non-traditional, multi-sectoral coalitions and community organizing networks with diverse agendas in challenging political, economic, and social environments.

Lisa received a master's degree in public health from the Loma Linda University School of Public Health, and a B.A. from San Diego State University. She serves on the Governor appointed California Complete Count Committee and on several statewide steering committees. She is also a yoga teacher and certified peace ambassador. Lisa lives in Sacramento with her husband and two children.

**CARL GUARDINO** Silicon Valley Leadership Group

Carl Guardino, one of Silicon Valley's most distinguished business and community leaders, is the President and CEO of the Silicon Valley Leadership Group, a public policy trade association that

represents more than 350 of Silicon Valley's most respected employers.

In February 2007, Governor Arnold Schwarzenegger appointed Guardino to a four-year term on the California Transportation Commission. He was reappointed twice by Governor Jerry Brown, and in 2019, Governor Gavin Newsom appointed him to his fourth consecutive four-year term.

In 2000, the San Jose Mercury News named Guardino one of the "Five Most Powerful" people in Silicon Valley, in a once-per-decade "Power Study." He received similar recognition in 2010.

Guardino has been the CEO of the Leadership Group since January 1997. Known throughout the region as a consensus builder, he has championed a number of successful ballot measures, especially in the areas of transportation and housing.



His transportation leadership includes successful management of ballot Measures A & B in 1996 that funded 19 key road and rail improvements with \$1.4 billion; and co-managed a 2000 traffic relief initiative that will generate some \$7.5 billion in local funds to bring BART to Santa Clara County, improve CalTrain and other transit improvements. In 2008, Guardino managed the successful Measure B (BART) campaign, which authorized a 1/8-cent sales tax for 30 years to fund a 16-mile Santa Clara County BART extension. Guardino led a three-year effort that culminated in "Measure B" on the November 2016 ballot, which will generate an additional \$6.5 billion in local funds for traffic relief improvements. Most recently, in June of 2018, Guardino co-led the Bay Area's first 9-County transportation measure — Regional Measure 3, which will generate \$4.5 billion in its first 25 years.

As a housing advocate, he co-created the Housing Trust Silicon Valley, which has helped 30,000 people afford homes in high-cost Silicon Valley by raising more than \$250 million in voluntary contributions. He also co-managed Prop. 46, the statewide Housing Bond, in 2002, co-chaired Prop. 1-C, the November 2006 statewide Housing Bond, and, most recently, co-led Propositions 1 and 2 on the November 2018 ballot, generating \$6 billion for affordable housing.

Guardino is the founder and race director of the annual Thanksgiving Day Applied Materials "Silicon Valley Turkey Trot," which has nearly 25,000 participants. In 14 years, it has raised nearly \$9 million for local charities. He is also the founder of the Google Santa Run Silicon Valley to benefit Christmas in the Park, and the Lam Research "Heart & Soles 5K" to place salad bars in Silicon Valley public schools. Guardino also is on the boards of California Stewardship Network and the California League of Conservation Voters.

Guardino was born and raised in San Jose and received a BA in political science from San Jose State University, where he is a Distinguished Alumnus. He is a member of Junior Achievement's Silicon Valley Business Hall of Fame, the recipient of the Lifetime Achievement Award from City Year and was the second recipient of the American Public Transit Association's Business Executive of the Year.







**CESAR DIAZ** State Building and Construction Trades Council of California

Cesar Diaz has served as Legislative & Political Director for the State Building & Construction Trades Council of California (SBCTC) since 2010 and had previously served as Deputy

Legislative Director since 2006. Cesar also served in the role as Policy Consultant and Senior Advisor for Community Relations to former Lieutenant Governor Bustamante. Prior to working in and around the Capitol, Cesar worked as a program associate for the California Academy of Family Physicians.

The SBCTC represents approximately 450,000 construction workers across California who belong to 180 individual local trades unions. As Legislative Director, Cesar manages the SBCTC legislative agenda to ensure its priorities are advanced. In addition, he is responsible for monitoring statewide regulatory agencies that may impact SBCTC members. He also works with the affiliates of the SBCTC and its 22 regional Building Trades Councils on legislative races and statewide political initiatives.

Cesar serves on the State Allocation Board as Governor Brown's appointee. In addition, he serves as a trustee on the California Construction Industry Labor-Management Cooperation Trust. He is also an executive board member of the California Democratic Party and a co-chair of the Resolutions Committee.

## WILFRED COOPER, SR. WNC

This year, the Carl A. S. Coan, Sr. Award for Public Service is presented to Wifred Cooper, Sr. for a lifetime of achievement for pioneering work in the advancement of affordable housing. The Carl A.S. Coan, Sr. Award is presented in recognition of outstanding commitment and leadership in the effort to provide decent, safe and affordable housing in this country. Established in 1984, it is named after Carl A.

S. Coan, Sr., who was widely regarded by his peers as one of the most effective housing staff directors on Capitol Hill.

Wilfred N. Cooper Sr. is the Chairman of the Board of WNC & Associates, Inc., a family enterprise he founded in 1971 for the purpose of investing in and developing quality, affordable housing for families and senior citizens of modest means. For over 48 years, Mr. Cooper has been a tireless advocate for affordable housing and a true pioneer in the industry.

In the late 1960s, prior to forming WNC, Mr. Cooper was asked to head up a team at North American Rockwell to investigate a new business venture manufactured housing — for the large aerospace company. This was a time when the nation was fast transitioning from President Kennedy's focus on lunar landings to President Johnson's war on poverty. When Mr. Cooper reported his findings to the senior officers, few of them understood what was presented to them.

Shortly after this, Mr. Cooper was laid off, taking with him one nugget — an understanding of the newly legislated incentives to invest private capital in affordable housing. Not one to waste time, he quickly founded WNC with nothing more than a young family, and the knowledge he gained from his research at the aerospace company. Since that time, WNC has grown to become one of the leading tax credit syndication firms in the nation with investments in over 1,350 properties in 48 states representing \$9.4 billion in assets.

While an entrepreneur at heart, advocacy for affordable housing has always been his calling card. When the low-income housing tax credit program was being guestioned by certain members of Congress in the 1990s, he testified before the Ways and Means Committee in support of the program, advocating for the need to maintain and provide a public partnership to address the nation's shortage of affordable rental housing. This commitment to advocacy continues to this day as he still finds the time to regularly meet with members of Congress on Capitol Hill and in their district.



Mr. Cooper is a senior life director of the National Association of Home Builders (NAHB). He is a current Trustee of BUILDPAC, NAHB's Political Action Committee, where he received Fund Raiser of the Cycle award for the two most recent consecutive congressional cycles. He is a life trustee of the National Housing Conference, a co-founder and director emeritus of the California Housing Consortium and a U.S. Vets Board of Director. Additionally, Mr. Cooper has been inducted into the Hall of Fame at the California Homebuilding Foundation (CHF). Mr. Cooper is the recipient of the CHF Lifetime Achievement Award, the NAHB Robert J. Corletta Award and the David Reznick Lifetime Achievement Award for his achievements in the industry. He volunteers his time with several nonprofit organizations and serves on the Board of Advisors for Jamboree Housing (a nonprofit developer of affordable housing) and the Tuberous Sclerosis Alliance.

Mr. Cooper is a U.S. Navy veteran with two years of active duty during the Korean War era (1951–1953) serving as a Hospital Corpsman and earned a bachelor of arts degree from Pomona College. He and his wife Kay Cooper recently celebrated their 60th wedding anniversary and enjoy spending time with their two sons and four granddaughters.

# 2019 POLICY SYMPOSIUM

Thank you to everyone who joined NHC at our Annual Policy Symposium this morning at the Hamilton, where this year's Gala honorees spoke on innovations in community development finance and lessons learned from the California Ballot Initiative.





The National Housing Conference has been defending the American Home since 1931. We believe everyone in America should have equal opportunity to live in a quality, affordable home in a thriving community. NHC convenes and collaborates with our diverse membership and the broader housing and community development sectors to advance our policy, research and communications initiatives to effect positive change at the federal, state and local levels. Politically diverse and nonpartisan, NHC is a 501(c)3 nonprofit organization.

#### POLICY AND ADVOCACY

NHC advocates for policies that support our American home. We promote reform and innovation that improves access to quality affordable homeownership and rental housing. Our deep understanding of housing policy and track record of leadership open doors for NHC and our members in the executive branch and on Capitol Hill.

Through our working groups and task forces, NHC brings members and partners together to exchange ideas and strategies to help maximize the greatest positive outcomes for housing. In 2019, NHC launched our Black Homeownership Working Group and a multi-year initiative to draft and enact a 21st century National Housing Act.

- Ensure access to affordable and sustainable mortgage credit to broadly serve homeownership-ready borrowers through a variety of public and private channels, including addressing the homeownership gap for communities of color and the impact of student loan debt on homeownership.
- Sustain, strengthen and modernize FHA's capacity and flexibility to meet the nation's housing financing needs while protecting the taxpayer's investment.

#### ADVANCE FEDERAL HOUSING POLICIES AND RESOURCES TO ASSIST LOW- AND MODERATE-INCOME FAMILIES

- Support and strengthen federal low-income housing programs to assist renters and homeowners, with a particular focus on the needs of vulnerable and underserved populations, including rural residents, veterans, people experiencing homelessness, seniors, and those affected by natural disasters.
- Advocate for federal housing resources during regulatory, tax and budget debates, including expansion and improvement of the Low Income Housing Tax Credit, housing infrastructure investment and other affordable housing and community development programs.

#### EXPAND SUCCESSFUL PUBLIC-PRIVATE PARTNERSHIPS IN COMMUNITIES OF ALL SIZES

- Revitalize and reinvest in places in economic distress by attracting new private investment, mitigating blight, preserving existing affordable housing and deploying government resources for community infrastructure, including affordable housing.
- Encourage private enterprise to serve the housing needs of all through real estate development, capital investment and financial services, including support for the acquisition, development and construction of affordable housing.
- Target policy solutions to the varying challenges of rural, suburban and urban places that link housing to health, transportation, education, workforce programs and other services.
- ► Create cost effective incentives for individuals and rental property owners to make new and existing buildings healthier, more resilient and more energyefficient.

#### DEVELOP A BROAD, BIPARTISAN NATIONAL HOUSING POLICY FOR THE UNITED STATES

- ▶ The United States is in the midst of a crisis over the growing shortage of affordable housing.
- ▶ The statutory infrastructure that supports the federal commitment to affordable housing is 33-70 years old.
